

GENERAL MEETING January 22 2014

President Dan Kruger called the meeting to order at 7:05.

Judge Cheryl B. Moss led the Pledge of Allegiance.

Judge Carolyn Ellsworth swore in the new Board.

Edith Byrd presented the Treasurer's report with a balance of \$ 3342.19.

Dan Kruger introduced the guest speaker, Judge Carolyn Ellsworth, who talked about the establishment of a new Appellate Court which will be on the ballot I November. This Court will be assisting the Supreme Court which is currently overloaded with cases. Nevada is not small any more, and the case load has grown exponentially while the Courts have remained the same. Today, it can take up to a year to get a case through the Supreme Court. The Supreme Court handles all that is appealed from District Court, as well as Bar Exam, discipline and censure. In 2012, 2500 cases were filed, 1900 as still pending. The Supreme Court Justices in Nevada have the highest caseload of any State Supreme Court in the country. With a new Appellate Court, the less serious cases could go from the Supreme Court to the Appellate Court while the Supreme Court would have time enough to handle the most important and complicated cases. With a new Appellate Court, cases would move quicker through the system. The operational cost of this proposed Court would be ca. 1.5 million dollars a year.
